

**DRAFT TERMS AND CONDITIONS FOR SIGNING THE MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE PUNJAB STATE TWENTY20 CRICKET ASSOCIATION® (PSTCA-005-N.Z™) & \_\_\_\_\_ District Twenty20 Cricket Association & \_\_\_\_\_**

**“Objective”**

Whereas the Punjab State Twenty20 Cricket Association® PSTCA-005™ is engaged in organisation promoting and developing the game of Twenty20™ in the state of Punjab by holding inter district T20 cricket championships, tournaments, camps, umpiring/event seminars and selecting the state teams participating in the national Twenty20 cricket championships of Indian Twenty20™ cricket Federation® &© ITCF INDIA™ and regulate and control the game of Twenty20 cricket & Twenty20 innings cricket in the State with the assistance of affiliated District Twenty20 cricket Associations. Towards this end in view the Executive committee of the PSTCA-005-N.Z has resolved to develop the playing infrastructure/coaching centres at the district Head quarters and percolating down from district to the schools level so as to instil keenness for the game among the school children and help institutions to build their cricket teams & setup coaching centres/academies. The effort is aimed at developing the game at grass root level.

**“OVER VIEW”**

The basic problem faced by the Punjab State Twenty20 Cricket Association® (PSTCA-005-N.Z™) is of non-availability of standard cricket playing fields dispersed all over the State. The effort cannot yield the full results unless the standard of the game at districts/Tehsils/Clubs/Schools/Collages and the State level. To achieve this end would require involvement of the schools/colleges/institutions having standard playing fields in overall system of coaching and competition by developing and using their facilities. As part of exercise and with a view to enlarging and ensuring better playing facilities of \_\_\_\_\_ the present Memorandum of Understanding has been entered into by the Punjab State Twenty20 Cricket Association® (PSTCA-005-N.Z™) & \_\_\_\_\_ District Twenty20 Cricket Association Regd. And \_\_\_\_\_ on \_\_\_\_\_ to ensure satisfactory results setting henceforth the obligations of each party.

**A) The Punjab State Twenty20 Cricket Association® (PSTCA-005-N.Z™) takes upon itself to:-**

- 1: Assist the \_\_\_\_\_ to lay the practice pitches and central pitches for matches
- 2: Assist the \_\_\_\_\_ to get the service of cricket coach for their coaching centre.
- 3: Assist the \_\_\_\_\_ to give the other technical support. Also association consider/select the \_\_\_\_\_ talent cricket players of Twenty20 Punjab State inter district cricket championships.

**B) In turn the \_\_\_\_\_ undertakes:-**

- 4: To make their net practice facility available for other selected district players from other institutions to play regularly in the ground.
- 5: The \_\_\_\_\_ will make available the ground for PSTCA T20 inter district cricket championships for various age groups for the competition to be organised by Punjab State Twenty20 Cricket Association® (PSTCA-005-N.Z™)
- 6: To extend full cooperation to the \_\_\_\_\_ District Twenty20 Cricket Association & PSTCA-005-N.Z in organising the coaching and competition at the ground.

**“COORDINATION AND MANAGEMENT”**

The management of ground shall lie with the \_\_\_\_\_. However for the purpose of coordination and facilitation the committee consisting of the sports Sec of \_\_\_\_\_ or his representative. Honorary Secretary of the \_\_\_\_\_ District Twenty20 Cricket Association and one technical person shall be constituted for the smooth running of coaching facilities.
