Any association fail to comply with these requirements will not be granted renewal till such time they furnish requisite information and accordingly will not be eligible to receive assistance from ITCF India.

3. All the affiliated T20 units of ITCF India are therefore, requested to ensure that the required information is submitted within the prescribed time schedule in order to enable this office to issue fresh affiliation certificate in the beginning of 2010.
