

“THE INDIAN TWENTY20 CRICKET FEDERATION ITCF INDIA”

REGULATIONS FOR REGISTRATION OF CRICKET PLAYERS IN INDIA

In these regulations:-

I.

(1) “Association” means Twenty20 cricket Association in India affiliated to the ITCF.

(2) “ITCF” means Indian Twenty20 Cricket Federation ITCF INDIA.

(3) “Register” means the register maintained by an association in which the names of the cricket players in the area under its jurisdiction are entered as these regulations.

(4) “Reregistered Player” means the person whose name is register in the register.

(5) “Regulation” means a regulation framed for registration purposes.

(6) “Period of Registration” means period from 31st December to 1st November.

II. “Regulations”

(1) No person whose name is not entered in the register maintained by an Association as per these regulations can play or participate in any of the Twenty20 & Twenty20 Innings cricket matches or tournaments recognised by the Indian Twenty20 cricket Federation ITCF INDIA or an affiliated association with ITCF or ITCF USA ie International Twenty20 Cricket Federation ITCF USA & its affiliated members either in India or abroad.

(2) Every affiliated association with ITCF shall maintain a register in which the names of the cricket players residing within the area of its jurisdiction are entered in accordance with these regulations.

(3) Any person who wishes to play in T20 cricket or Tournament, National championships, State/Zonal/District tournaments also club matches recognised by the Indian Twenty20 cricket federation ITCF or an Association shall make an application in the Form given to the Association of the area its jurisdiction in which he has been residing for more than six months.

(4) An application for registration in the register shall furnish truly all the particulars required by the application form ie (*ITCF PLAYERS*

REGISTRATION FORM) & shall duly signed a declaration contained in it and shall undertake to observe the conditions set out in the declaration signed by him.

- (5) On receipt of the application for registration, the Association shall scrutinise it and on being satisfied that the statement made in the application are true. Shall enter the name of the applicant in the register maintained by it.**
- (6) If a person whose name has been entered in the register is found to have furnished incorrect particulars in the application or if the fails to comply with or violates the conditions contained in the declaration signed by him, the association may remove his name from the register after holding a proper enquiry if it finds that he is guilty of such noncompliance or violation. A copy of the order removing a person's name from the register shall be submitted to the ITCF. The ITCF may either suo moto or on an appeal by the concerned person be presented within 30 days of the date of the order confirm the order or may issue any appropriate direction in modification of the order or may set aside the order. The Association shall submit all the relevant records of enquiry to the ITCF for taking action under this regulation.**
- (7) A person whose name is removed from the register may again be readmitted into the register by the Association at its discretion but where his name is removed from the Register by an order passed by the ITCF his name may be again entered in the Register only on an order passed by the ITCF.**
- (8) Notwithstanding anything contained in Regulation 6, if the ITCF is of the opinion that a person whose name is Registered as a Cricket Player in a register maintained by an Association should be removed from the register on account of any noncompliance or violation by such person of the terms of the declaration in the application or registration or has committed any misconduct unbecoming of a cricket player or if he uses or in any way be concerned in the use or distribution of illegal drugs or involve in match fixing the ITCF may issue a direction to the concerned Association to remove his name from the register and the Association shall forthwith comply with such direction. The ITCF may pass such an order directing the removal of the name of the person from the Register under this regulation only after holding a proper enquiry. A person whose name is so remove from the Register may be readmitted as a Registered Player of the concerned Association by a subsequent order passed by the ITCF at the**

discretion of the ITCF. The power of the ITCF under this regulation is independent of and in addition to its power under Regulation No 7.

- (9) The Association shall on being asked by the ITCF all relevant information to the ITCF about any person whose names is entered in the Register for being used by the ITCF in discharge of its duties and powers.
- (10) No registered player can play or participate in Twenty20 Cricket match or tournament/Championships/Trophy's not recognised by the Indian Twenty20 Cricket Federation ITCF India or Association or the International Twenty20 Cricket Federation ITCF USA or its affiliated members without the written permission of the ITCF either in India or abroad.
- (11) No registered player can participate or play in a Twenty20 cricket match or tournament organised as Festival/Charity/Benefit Match or Tournament not registered with or approved by ITCF or Association or ITCF USA or any of its affiliated members without the written permission of the ITCF either in India or abroad. If any of the registered player participate in any of the tournaments of matches not registered by Indian Twenty20 Cricket Federation ITCF or International Twenty20 Cricket Federation ITCF USA & its affiliated members without the written permission from ITCF INDIA, they are liable for deregistration and will be registered only after a gap of one year (12 months) which period the ITCF may waive at its discretion.
- (12) The Indian Twenty20 Cricket Federation ITCF INDIA may issue from time to time further directions to the affiliated Twenty20 cricket Associations for the due compliance with these Regulations.
